Dear Patient, July 15, 2024

We are very fortunate in this country to have access to good health care paid for through our taxes. However, many physician services are not covered by provincial health insurance plans. These services require significant time and resources to administer, particularly as the demand for uninsured services has increased dramatically in the past few years. As office expenses rise alongside increasing health care costs, government cutbacks, and inflationary pressures, we are unable to provide these services free of charge. Therefore the payment of these services remains the responsibility of the patient.

We would like to touch on two issues in particular:

Renewals of prescriptions by phone or fax: During any office visit, you should request a renewal of necessary prescription(s) if appropriate. Each time a request is made for a prescription outside of a scheduled appointment the patient's chart needs to be accessed, reviewed, and the prescription needs to be appropriately documented and sent to the pharmacy. If you sign up for the Annual Block Fee for uninsured services prescription renewals will be covered, otherwise there will be a charge for each request. Please make sure you allow several days' notice when requesting prescription renewals.

Email consultation requests: As outlined in our accompanying Annual Newsletter as well, requests for medical advice via email remain uninsured (ie. not covered by OHIP). If you send your doctor a message for which a reply is expected/requested, a charge will be incurred through our Uninsured Services program, if not already covered by the Block Fee. There is no charge to receive messages from our office.

Signing up for the all-inclusive Annual Block fee can amount to substantial savings if uninsured services arise over the year. Included with this letter is a list of uninsured services which are covered by paying the Annual Block Fee.

Those who choose not to sign up for the optional Annual Block Fee may pay for individual uninsured services at the time the services are provided.

Should you wish to submit payment for the Annual Block Fee using a debit or credit card, you may do so online by going to www.doctorsservices.ca/online-payment or by telephone to Doctors Services. Our clinic continues to use DOCTORS SERVICES to administer this plan. Any questions or correspondence regarding the Uninsured Services plan should be directed to them by phone 1-866-423-8267 and NOT to our office.

Please note: Signing up for the annual block fee is entirely at your discretion. No patient will be denied services based on ability to pay.

We look forward to continuing to provide your primary medical care to ensure that you receive the best possible health outcomes.
